# **FATE Wing arranges Taxpayers' Interaction seminars**

FBR's Facilitation And Taxpayers Education (FATE) Wing launched a major national campaign for public awareness regarding e-services provided by FBR and the documentation of economy. The campaign consisted of two components:

In the first, interactive sessions were held with the representatives of Chambers of Commerce & Industry and Tax Bar associations in Islamabad, Karachi and Lahore. The sessions were chaired by then Chairman FBR, accompanied by Member IR, Member Customs and Member FATE.

In the second component, seminars were held in all field offices of FBR, which were attended by people from various segments of society including tax consultants, president and members of chambers of Commerce & Industry, and representatives of local trade bodies.

The seminars provided an opportunity for the FATE wing to inform the taxpayers and stakeholders about the initiatives launched by the Wing for facilitation of taxpayers regarding tax matters. Taxpayers also availed this opportunity to highlight their grievances and they put forward queries related to tax laws and systems. Taxpayers also highlighted various shortcomings in the Income Tax Form and issues related to e-filling of Sales Tax Returns.

He highlighted the performance of RTO, Faisalabad during a formal briefing followed by presentations by Commissioners Inland Revenue on implementation of decisions of the FTO.

The Chief Commissioner informed the FTO that a complaint cell has been established to ventilate grievances of taxpayers. The Honorable FTO urged the officers to achieve of revenue targets, but through good governance.



### **Training sessions on e-filing Sales Tax Returns at RTO Faisalabad**

A seminar on e-Filing of monthly Sales Tax returns was arranged on 24th September, 2011 at RTO Faisalabad. Officers attending Mid Career Management Course at National Institute of Management Lahore and Kashmir Institute of Management Muzaffarabad, visited RTO, Multan on 16-11-2011 and 28-11-2011.

Addl Commissioner (IR) Mr. Imran Lateef Minhas briefed them on reforms in FBR and integration of domestic taxes and gave an overview of revenue generation through Income Tax, Sales Tax and FED at National and Regional levels.

Addl Commissioner LTU Lahore Ch. Muhammad Tarique gave a presentation on reformed structure of LTU, Lahore.



### **Meeting of the advisory council, RTO Bahawalpur**

The first advisory council meeting was held in RTO, Bahawalpur on 30.09.2011.

Mr. Gholam Kazim Hosien, Chief Commissioner IR, RTO, Bahawalpur welcomed the representatives of Business/Trade Bodies and Tax Bars of District Bahawalpur, Rahim yar Khan & Bahwalnagar and solicited their cooperation to achieve revenue targets. The participants brought up issues regarding Broadening of Tax Base, Withholding tax and enforcement of Returns and specifically emphasized the issue of Annexure-D



of the Tax Return form, and Flood surcharge payable along with the Tax Return.

Answering a question regarding delay in issuance of sales tax refunds the Chief Commissioner said that the record of sales tax cases has not been transferred from RTO, Multan which is causing the delay.

During the meeting, it was also pointed out that district management has not provided land for building of RTO, despite having received the payment in advance. The Chief Commissioner urged the members of the Council to extend their cooperation and support for allotment of suitable piece of state land for RTO building.

After a brief introduction and visit of DOT premises they were briefed about Specialized Training Programme (STP) and in-service training of officers and officials of Inland Revenue. The team was also apprised of the outstation training programmes for the officials of BS-7 to BS-15.

Academic block on 2nd Floor of Tariq Aziz block: Conference Room, Lecture Room, Syndicate Room



### **Workshops and Training Courses for Officers of Inland Revenue**

The Directorate General of Training and Research (IR) has been organizing a number of workshops on Sales tax Act, 1990 and Federal Excise Act, 2005 since July, 2011. A series of such workshops were conducted from 7th to 8th September, 2011 for BS 17 and 18 officers and on 10th September, 2011 for officers in BS 19 and 20. Similar workshops were also conducted for officers of BS 17 and 18 at different dates.

Workshops were also held on audit under Sales Tax Act, 1990 for officers of BS-17 and 18 from 17 to 19 October and 24 to 26 October, 2011. These were in addition to a refresher training course organized for staff of IR (BS-7 to 5), on various aspects of Income Tax Ordinance and Sales Tax Law.

Mr. Mujahid Naeem of PRAL (Pakistan Revenue Automation Ltd.) imparted training to the officials. All the participants received hands-on training on e-filing of Income Tax Returns after a detailed briefing on the procedure of e-filing and the tools used therein. The workshop was of immense importance keeping in view the timeline for the filing of Income Tax Returns in September & October.

At the end of the workshop, Mr. Shahid Anwar Khan, Chief Commissioner, RTO, Rawalpindi thanked all the participants for effective utilization of the opportunity.



Another workshop on e-filing was held at RTO Rawalpindi on 15th August 2011. The workshop was attended by the representatives of Military & Civil Departments as well as private organizations.

Mr. Farhan Baig, Manager PRAL demonstrated the whole procedure of e-filing to the participants. Questions & queries were addressed by the senior management of RTO Rawalpindi.

### Visit of World Bank's mission on impact of recent organizational changes, meeting of revenue targets and training program, to RTO Rawalpindi

Mr. Abdul Hafeez, Chief Commissioner Inland Revenue, RTO, Rawalpindi received Mr. Taqi Shrif and Mr. Orlando Reos along with FBR's officials at Rawalpindi RTO Building on 22-07-2011. The mission of World Bank was to analyze the Impact of Recent Organizational Changes, achievement of Revenue Targets, Training Programs, etc. The mission was briefed regarding all of the above mentioned agenda items. The team members lauded the efforts of the Chief Commissioner and his entire team for effective performance in all requisite and allied areas.

### **Directorate of Training, Lahore Research Syndicates of 38th STP**

Research is prerequisite of development and is a central activity at all progressive academic institutes. Research has also been made integral part of specialized training programme.

In view of this, the probationary officers of 38th STP (IR) Lahore have been divided into six Research Syndicates to prepare research papers on following topics:

- 1. Energy crisis: Its impact on the economy and revenues in Pakistan. What options are available to address the Problem?
- 2. Reasons for rapid growth of banking sector in Pakistan and its impact on revenue generation.
- 3. Role of Automobile Industry in economic development of Pakistan. Its impact on growth: negative as well as positive.
- Contribution of cement Industry in economic development of Pakistan. 4.
- Property boom: its impact and taxability. 5.
- 6. Textile sector is the back bone of economy of Pakistan. The ills faced by the sector and its contribution towards economic development.

### Phase-wise launch of WeBOC successfully completed

WeBOC (Web Based One Customs), is an indigenously developed, web-based computerized clearance system, providing end to end automated customs clearance of import and export goods.



Under the guidance of the then Member (Customs) Mr. Mumtaz Haider Rizvi, the system was developed jointly by the Pakistan Customs and PRAL and was first implemented on trial basis at Port Muhammad Bin Qasim for non PaCCS export commercial cargo on 13th April 2011 and on 9th May 2011 for non-PaCCS home consumption import cargo. Subsequently, WeBOC was further rolled out at Port Qasim International Container Terminal (PQICT), Karachi for all cargo on 23rd September 2011, Pakistan International Container Terminal (PICT), Karachi on 17th December 2011 and Karachi International Container Terminal (KICT), Karachi on 7th January 2012, in a phase wise manner.

WeBOC's Risk Management System (RMS), identifies / implements risk parameters in relation to the import / export goods, importers, clearing agents, origin and destination of consignments etc. Based on such risk parameters, the system automatically segregates / channelizes import and export consignments into green (cleared by the system without examination), yellow (cleared after examination of documents) and red (complete examination of the consignment and its documents) categories.

Before the introduction of WeBOC in May 2011, the computerized customs clearance PaCCS (Pakistan Customs Computerized System) was in operation. Now, all the functions of PaCCS have been successfully taken over by WeBOC.

Though all the essential components of the system have been fully implemented, certain areas / modules of the WeBOC system are in the process of development. Upon completion of all modules of the system, WeBOC will be rolled out to all customs Collectorates of the country.

The salient contributions of HRM Wing of FBR are preparation of job descriptions, launching of the internal job postings and an ambitious training programme. In addition, the Wing has accomplished a workforce planning exercise for the field formations of IRS taking into consideration the number of taxpayers and the revenue potential of each tax office.

The HRM Wing believes that Human Resource is the most valuable asset of any organization. This has prompted the creation of an HRM blog for the employees of FBR. The purpose is to provide a common platform to officers of FBR for sharing views and staying abreast of changes. This initiative has been taken with a view to ensure open communication channels. All officers are encouraged to access the blog through HRM portal, participate actively and make the blog an effective mode of communication.

The Wing is currently finalizing modalities for organizing training programmes in collaboration with the German donor agency GIZ. In the initial phase, focus would be to arrange training sessions for officers of LTUs encompassing the international taxation concept of transfer pricing. The programme is set to be rolled out in March, however in order to help our officers brace for the complexities of the transfer pricing issues, the HRM Wing has planned a preparatory session to sensitize the officers of the critical issues of International taxation.

The Wing will continue pursuing the highest ideals in terms of establishing HR processes for FBR so that its workforce is at par with any successful national/international organization.
